If necessary, the Final Hearing on any interim orders entered regarding this pleading will be held on May 12, 2017, at 9:30 a.m. at 215 Dean A McGee Ave, 9th Floor, Oklahoma City, OK 73102, before Judge Sarah A. Hall.

Eateries, Inc. ("Eateries") and GRP of Zanesville, LLC ("Zanesville"), debtors and debtors-in-possession in the above-captioned cases (collectively, "Debtors"), hereby file this motion (the "Motion") for entry of an order under 11 U.S.C. §§ 105, 363 and 507 authorizing the Debtors to (i) pay pre-petition employee obligations and related amounts, (ii) confirming the Debtors' right to continue employee programs on a post-petition basis, (iii) confirming right of Debtors to pay withholding and payroll-related taxes; and (iv) directing banks to honor pre-petition checks for employee obligations. In support of this Motion, the Debtors rely on the Affidavit of William C. Liedtke, III, Vice-President and Managing Member of Debtors, in Support of Debtors' Chapter 11 Petitions and First Day Motions (the "First Day Affidavit"). In further support of the Motion, the Debtors respectfully represent as follows:

#### **JURISDICTION AND VENUE**

- 1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding under 28 U.S.C. § 157(b)(2). Venue is proper under 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory predicates for the relief requested herein are §§ 105, 363 and 507 of the Bankruptcy Code.

#### **BACKGROUND**

- 3. On April 18, 2017 (the "Petition Date"), the Debtors filed voluntary petitions for relief pursuant to Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Western District of Oklahoma (the "Bankruptcy Court").
- 4. The Debtors continue to operate their businesses as debtors-in-possession pursuant to §§ 1107(a) and 1108 of the Bankruptcy Code. The U. S. Trustee has not yet appointed any official committees in these cases, and no request has been made for the appointment of a trustee or examiner.
- 5. These cases are jointly administered pursuant to this Court's Order entered April 18, 2017 [Dkt. No. 5] A description of the Debtors' business, the reasons for filing these Chapter 11 cases and the relief sought from this Court to allow for a smooth transition into operations under Chapter 11 is set forth in the First Day Affidavit. [Dkt. No. 10]. The Debtors hereby adopt and incorporate the First Day Affidavit as if fully set forth herein.

### RELIEF REQUESTED

6. By this motion, the Debtors request entry of an order authorizing, but not directing, the Debtors to pay, continue or otherwise honor pre-petition obligations (collectively, the "Pre-petition Employee Obligations") to or for the benefit of their current employees (collectively, the "Employees") for salaries and other compensation and benefits under all plans, programs and policies implemented by the Debtors prior to the Petition Date (as set forth below,

the "Employee Programs"). The Debtors seek immediate authority to make payments to Employees on account of Pre-petition Employee Obligations.<sup>3</sup>

- Specifically, (i) under §§ 105(a) and 363(b)(1) of the Bankruptcy Code, the Debtors ask the Court to authorize, but not direct, the Debtors to pay any obligations arising under the Employee Programs that were accrued or earned but unpaid as of the Petition Date; and (ii) under § 363(c)(1) of the Bankruptcy Code, the Debtors request that the Court confirm their rights to continue each of the Employee Programs during the pendency of these cases, to make payments as required by the Employee Programs, and to make payments in connection with expenses incurred in the administration of any Employee Program.<sup>4</sup>
- 8. The Debtors also seek authorization to pay any and all local, state, and federal withholding and payroll-related or similar taxes relating to the Pre-petition Employee Obligations, including but not limited to, all withholding taxes, Social Security taxes and Medicare taxes. In addition, the Debtors seek confirmation that they are permitted to pay to third parties any and all amounts deducted from Employee paychecks for payments on behalf of Employees, including, without limitation, garnishments, charitable contributions, support payments, tax levies, benefit plans, insurance programs and other similar programs.
- 9. The Debtors further request that, with respect to any Employee Programs and Pre-Petition Employee Obligations that are administered or paid through a third-party administrator,

agent, consultant or provider (the "Administrators"), the Debtors be expressly authorized to pay any pre-petition fees of the Administrators and to continue such payments post-petition in the ordinary course of their business in order to ensure the uninterrupted delivery of payments or other benefits to the Employees.

10. In aid of the foregoing relief, the Debtors request that the Court authorize and direct all banks to receive, process, honor and pay any and all checks drawn on the payroll and other bank accounts used by the Debtors to satisfy their Pre-petition Employee Obligations, whether presented before, on or after the Petition Date, and authorizing the banks to rely on the representations of the Debtors as to which checks are subject to this Motion, provided that sufficient funds are on deposit in the applicable accounts to cover such payments. The Debtors additionally request that the court authorize the Debtors to issue new post-petition checks to replace any checks that may be dishonored and to reimburse any expenses that Employees may incur as a result of any bank's failure to honor a pre-petition check. Any payments made by the Debtors in connection with the relief requested herein shall be subject to a cash collateral order entered by this Court.<sup>5</sup>

### **BASIS FOR RELIEF**

11. The Debtors' ability to preserve their businesses and maintain value is dependent on the continued enthusiasm, services and expertise of their Employees. Due to the disruption and uncertainty that typically accompanies a Chapter 11 filing, the Debtors believe that the morale of their Employees may be adversely affected if they are not able to assure them that they will be fully paid for the work they have performed or will perform, whether before or after the

The Debtors have filed concurrently herewith an Expedited Motion for Interim and Final Orders (A) Authorizing the Debtors to Use Cash Collateral, (B) Approving Post-Petition Financing, (C) Granting Liens and Providing Super-Priority Administrative Expense Status Pursuant to 11 U.S.C. §§ 363 and 364, (D) Scheduling a Final Hearing, and (E) Granting Related Relief.

Petition Date, and can rely on the benefits provided to them under the Employee Programs. The Debtors have determined that continuation of the Employee Programs will be vital to their ability to preserve key Employee morale during the pendency of these Chapter 11 cases and to reduce the level of Employee attrition that might otherwise occur. Minimizing such attrition and the consequent disruption to the Debtors' business operations is critical to the Debtors' ability to preserve and enhance value for the benefit of the Debtors, their estates and all stakeholders.

12. In addition, if the Debtors fail to pay the Pre-petition Employee Obligations in the ordinary course, their Employees will suffer extreme personal hardship and, in some cases, may be unable to pay their basic living expenses. Such a result would have a highly negative impact on employee morale and likely would result in unmanageable turnover, thereby resulting in immediate and irreparable harm to the Debtors and their estates. Honoring the Pre-petition Employee Obligations will minimize the level of disruption and preserve the loyalty of Employees so necessary for any successful reorganization.

# I. PAYMENT OF PRE-PETITION SALARY, BENEFITS AND OTHER COMPENSATION

- 13. As of the Petition Date, the Debtors' aggregate workforce consists of approximately 375 Employees. All 375 Employees are employed by Eateries, and of those employees, 288 are part-time/hourly, 61 are full-time/hourly, and 26 are full-time/salaried.
- 14. All full-time Employees, whether salaried or paid hourly, are eligible to participate in the Employee Programs. Debtors do not maintain a severance or retention program for their employees and all employees are employed on an at-will basis. None of the Employees are covered by a collective bargaining agreement.
- 15. Doug Davis serves as president of operations of Eateries. Tim Grover and Matt Fite serve as regional directors of operations. The remaining management positions held by

William C. Liedtke, III (Vice President, Secretary, and Director) and Preston Stockton (President and Director), are outsourced through third-parties and their salaries and benefits are not administered by Eateries.

- 16. In the ordinary course of the Debtors' business, with limited exceptions, the Debtors' Employees earn and are paid salaries and/or other compensation on a bi-weekly basis on Wednesday.<sup>6</sup> All employees (with the exception of the two West Virginia restaurant locations) were most recently paid on Wednesday, April 12, 2017.
- 17. As a general matter, the Debtors employ Abacus Systems Solutions, LLC ("Abacus")<sup>7</sup> to process the Payrolls beginning the Monday the week before payroll is issued using internal time keeping records of Eateries. Abacus then pays the salaries and related employment benefits to Employees via direct deposit on a bi-weekly basis with the most recent payments being issued on April 12, 2017 (collectively, the "Payrolls"). In addition, the Debtors are required by law to (i) match the Social Security and Medicare taxes, (ii) based on a percentage of gross payroll, pay additional amounts for state and federal unemployment insurance and (iii) remit these payroll taxes to various taxing authorities (the "Employer Payroll

Taxes"). With the Debtors' current employee level, each Payroll, including all applicable Employer Payroll Taxes, totals approximately \$157,000.00.8

- 18. A payroll report for the Debtors' most recent pay period is attached hereto as Exhibit "1". The Debtors request the authority to pay and continue to pay the regularly scheduled Payrolls, including Employer Payroll Taxes, in the ordinary course of business, including any pre-petition amounts that may have accrued but not become payable as of the Petition Date. An updated payroll report showing all relevant amounts due as of the Petition Date will be presented at the hearing on this Motion.
- 19. In the ordinary course of business, the Debtors also cause certain Payroll deductions to be automatically made for Employee obligations, such as federal income taxes, Social Security and Medicare contributions, court-ordered garnishment and support payments, benefit plan insurance programs, and other similar programs (collectively, the "Deductions").
- 20. To the extent that the Debtors are holding funds belonging to Employees that are collected from Employees and remitted to others, the Debtors maintain that such funds are not property of the bankruptcy estates. The amounts deducted are generally held in trust by the

Debtors until they are forwarded to third parties. However, in an abundance of caution and to the extent that such funds relate to pre-petition periods, the Debtors seek authority to remit the applicable Deductions to appropriate governmental authorities and other third parties in accordance with the Debtors' regular policies and procedures. 11

#### II. PAYMENT OF REIMBURSABLE EXPENSES

- 21. Prior to the Petition Date and in the ordinary course of business, the Debtors reimbursed Employees for reasonable expenses incurred in performing their jobs, including, but not limited to, business-related travel, automobile expenses, lodging and meals (the "Reimbursable Expenses"). Reimbursable Expenses were incurred on behalf of the Debtors in the ordinary course of business with the expectation that such expenses would be reimbursed in accordance with past practice. It would be inequitable and would cause harm to employee morale to deny reimbursement of such expenses. Moreover, it is essential to the continued operation of the Debtors' business that the Debtors be permitted to continue to reimburse Employees for such business-related Reimbursable Expenses incurred in the ordinary course of the Debtors' business, whether incurred by an Employee on a pre- or post-petition basis.
- 22. Under the Debtors' reimbursement policy, the Employees must submit expense reports, including receipts or the reimbursement may be denied. Because Employees do not always submit reimbursement claims promptly, it is difficult to determine the exact outstanding amount at any one time, but these amounts are nominal. As of the Petition Date, the Debtors have received, but not paid, expense reimbursement requests totaling approximately \$1,256.91.

# III. CONTINUATION AND PAYMENT OF PRE-PETITION EMPLOYEE BENEFITS

- 23. The Debtors' Employees are eligible for various standard employee health and welfare benefits, including, without limitation, (a) medical insurance and prescription drug coverage; (b) dental insurance; (c) vision insurance; and (d) short term disability, long term disability, basic life and accidental death and dismemberment insurance ("Disability and AD&D") (collectively, the "Employee Benefits").
- 24. Eligibility: All salaried employees become eligible for (a) medical insurance and prescription drug coverage; (b) dental insurance; and (c) vision insurance coverage on the first day of the month following thirty (30) days from hiring date. Full time employees become eligible after being employed for one (1) full year of employment upon establishing the worked for an average of 30 hours per week during the full year of employment ("Eligible Employees").
- 25. Medical Insurance and Prescription Drug Coverage: Eligible Employees are offered medical insurance and prescription drug coverage through a third party plan administrator, National General. National General offers plans through Meritain and Cigna. Medical plan participants are also offered prescription drug coverage provided by the same carriers. For these standard health benefits, on base plan Eateries pays 54%. On the remaining non-standard plans, Eateries' contribution ranges from approximately 23% to 36% and employees pay the remaining percentage. On average, the Debtors remit approximately \$17,000.00 per month to National General, \$9,000.00 of which is paid directly by the Debtors and approximately \$8,000.00 is deducted from employee pay.
- 26. Dental Insurance: Eligible Employees are offered dental insurance through Delta Dental of Oklahoma. For these standard health benefits, employees pay the entire premium. On

average, the Debtors remit approximately \$2,000.00 per month to Delta Dental of Oklahoma, all of which is deducted from employee pay.

- Vision Insurance: Eligible Employees are offered vision insurance through 27. Eyemed Vision Care. For these standard health benefits, employees pay the entire premium. On average, the Debtors remit approximately \$300.00 per month to Eyemed Vision Care, all of which is deducted from employee pay.
- 28. Disability and AD&D Insurance: Only salaried employees are eligible for Life Disability and AD&D Insurance. Salaried employees are offered basic disability and AD&D coverage through Lincoln Life Insurance. The company provides for 100% of the premium payment on a \$15,000.00 policy for assistant managers; general managers and above are provided with a \$50,000.00 policy at no expense to the employee. On average, the Debtors pay approximately \$1,150.00 per month to Lincoln Life Insurance. Premium payments for amounts in excess of those covered by Eateries are deducted from Eligible Employees wages and remitted to the carrier by the Debtor.
- 29. As of the Petition Date, the Debtors were obligated to pay certain premium contributions to or provide benefits under the foregoing programs, plans, and policies. The Debtors estimate the average monthly cost paid directly by the Debtors (not including deductions from employee pay<sup>12</sup>) for Eligible Benefits is \$10,150.00. That total is calculated upon the following summary of estimated monthly fees (i) National General is owed \$9,000.00 for medical insurance and (ii) Lincoln Life is owed \$1,150.00 for Disability and AD&D.

30. By this Motion, the Debtors seek to pay in the ordinary course of business all amounts owed by the Debtors for expenses and fees relating to Employee Benefits, including those incurred prior to the Petition Date.

### IV. PAID TIME OFF BENEFITS

31. All Eligible Employees receive paid time off ("PTO") for vacation, personal, family illness, or sick days as part of their overall compensation. The PTO benefits are calculated based on the anniversary date, which is the first day the Employee reported to work. Employees are only eligible to accrue PTO while on active status. In general, vacation is accrued annually based on years of employment at the Debtors as follows:

- 32. Employees are not entitled to carry forward PTO benefits to the next year.
- 33. Employees leaving Eateries, Inc. due to voluntary resignation, retirement or dismissal will be eligible to be paid for their unused vacation days as long as: (1) upon resignation or retirement, two weeks' notice is provided; and (2) termination is for reasons other than gross misconduct, gross negligence, or other documented terminable offenses

34. PTO is paid at the employee's base rate at the time the leave is taken. PTO pay does not include overtime or any special forms of compensation such as incentives, commissions, bonuses, or shift differentials.

35. The Debtors anticipate that Employees will utilize PTO post-petition including certain PTO that may have accrued before the Petition Date. The Debtors seek authority (but not direction) to honor all earned PTO in the ordinary course consistent with the existing guidelines and policies described in this section, regardless of whether it accrued during the pre- or post-petition period.

### V. WORKERS' COMPENSATION PROGRAM

36. The Debtors maintain a "first dollar" insurance policy for workers' compensation claims in compliance with applicable state and federal laws and numerous contracts with customers. This workers' compensation insurance is funded by Eateries and no part of the premium can be paid by the Employee. The Debtors request the authority to satisfy workers' compensation obligations, including those incurred prior to the Petition Date and to pay any applicable premiums.

### VI. DIRECTION TO BANKS REGARDING PRE-PETITION CHECKS AND ELECTRONIC TRANSFERS

37. The Debtors request that, to the extent of funds on deposit, all applicable banks and other financial institutions be directed to receive, process, honor and pay all checks or electronic transfers drawn on any of the Debtors' accounts relating to the Employee Obligations, Deductions, Employment Taxes, Independent Contractors and Temporary Workers as outlined above, whether presented before or after the Petition Date. The Debtors request that such banks be authorized and directed to rely on the representations of the Debtors as to which checks are in payment of the Prepetition Employee Obligations. To the extent that any such checks are

refused payment, the Debtors additionally request authority to issue replacement checks and to reimburse their Employees from any loss resulting from the dishonoring of such payments.

### **APPLICABLE AUTHORITY**

- 38. Pursuant to §§ 507(a)(4) and 507(a)(5) of the Bankruptcy Code, certain claims for compensation are accorded priority in payment in an amount not to exceed \$12,475 for each employee (to the extent such amounts accrued within 180 days of the petition date). The overwhelming majority of employees who are owed compensation amounts for prepetition services are within the statutory priority cap of §§ 507(a)(4) and 507(a)(5). Thus, granting the relief requested is consistent with the Bankruptcy Code's purpose of ensuring the employees are paid in full up to the statutorily imposed limit due to the priority status of their claims.
- 39. This Court has authority to grant the relief requested herein pursuant to §§ 105(a) and 363(b) of the Bankruptcy Code. Section 363(b)(1) of the Bankruptcy Code provides that "[t]he trustee, after notice and a hearing, may use, sell, or lease, other than in the ordinary course of business, property of the estate." 11 U.S.C. § 363(b)(1). Moreover, § 105(a) of the Bankruptcy Code allows the Court to authorize payments on account of certain pre-petition claims when necessary. This is generally referred to as the "necessity of payment rule" or the "doctrine of necessity." See *In re NVR, L.P.*, 147 B.R. 126, 127 (Bankr. E.D. Va. 1992) (stating that, under § 105(a), a court "can permit pre-plan payment of a pre-petition obligation when essential to the continued operation of the debtor"); *In re Ionosphere Clubs, Inc.*, 98 B.R. 174, 175 (Bankr. S.D.N.Y. 1989) (stating that a bankruptcy court's use of its equitable powers to "authorize the payment of pre-petition debt when such payment is needed to facilitate the rehabilitation of the debtor is not a novel concept"); *In re Lehigh & New England Ry. of a claim which arose prior to reorganization is essential to the continued operation of the [business] during the reorganization, payment may be authorized even if it is made out of corpus"). 13

- 40. The continued service and dedication of the Employees is critical to the Debtors to maintain value of their assets as they move forward with a sale process. Courts have invoked their § 105(a) equitable powers on numerous occasions to authorize the payment of prepetition employee claims when, as in these cases, nonpayment or delay would damage a debtor's business.
- 41. Similar relief to that requested herein has been granted in this district relating to the payment of prepetition employee claims in the ordinary course of business. See In re GMX Resources, Inc., et al, 13-11456 and affiliated entities at Dkt. No. 74 (Bankr. W.D. Okla., April 3, 2013).
- 42. In addition, courts in other jurisdictions have granted motions for the payment of prepetition employee claims. See Sheltered Work-Activity Program, Inc. 11-80965 (Bankr. E.D. Okla., July 5, 2011); TSG, Inc. and TSG Holdings-Prague, LLC, Case No. 06-80899 and 15 affiliated entities (Bankr. E.D. Okla., November 8, 2006); In re ATP Oil & Gas Corp., Case No. 12-36187 (Bankr. S.D. Tex. August 21, 2012); In re Cano Petroleum, Inc., Case No. 12-31549 (Bankr. N.D. Tex. March 16, 2012); In re Dynegy Holdings, LLC, Case No. 11-38111 (Bankr. S.D.N.Y. November 9, 2011); In re Otero Cnty. Hosp. Ass'n, Inc., Case No. 11-13686 (Bankr.

- 6. The Debtors are authorized, but not required, to continue their retention of any third-party administrators, agents, consultants or providers post-petition, and are further authorized to pay any prepetition claims of such Administrators arising from the Employee Programs as necessary to insure the uninterrupted delivery of Employee payments or benefits, and to continue such payments post-petition in the ordinary course of their business in order to ensure the uninterrupted delivery of payments or other benefits to the Employees.
- 7. The banks upon which any checks are drawn in payment of the Prepetition Employee Obligations, either before, on or after the Petition Date, are authorized and directed to honor such checks upon presentation of any such checks. Such banks are authorized and directed to rely on the representations of the Debtors as to which checks are in payment of the Prepetition Employee Obligations
- 8. The Debtors are authorized to issue new post-petition checks to replace any checks that may be dishonored notwithstanding the foregoing authorization, and to reimburse any expenses that Employees may incur as a result of any bank's failure to honor a prepetition check.
- 9. Any party receiving payment from the Debtors is authorized and directed to rely upon the representation of the Debtors as to which payments are authorized by this Order.
